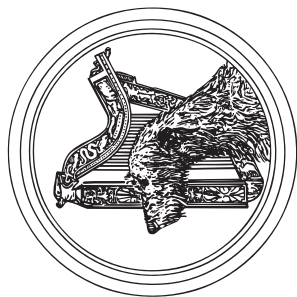

## Trial Hours

**Roll Call & Inspection:** 8:00 AM. Hounds not present at roll call will be scratched and are not eligible for refund of entry fee.

**Trial Hours:** 7:00 AM until one hour past the completion of the last scored course of the day.

## Eligibility Requirements

Only purebred Irish Wolfhounds may be entered in the regular stakes. All entries shall be individually registered with the American Kennel Club, the Federation Cynologique Internationale, an ASFA-recognized or ASFA Board approved registry.

**Incomplete, unsigned, conditional, or late entries WILL NOT be accepted. Entry forms of minor owners/handlers (under the age of 18) must be signed/co-signed by a parent or guardian. The IWCA will not be responsible for accidents at this trial. ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL. Substitutes for lame or in-season hounds are allowed if substitute has same owner and the Field Secretary is notified at least one hour prior to roll call.**

**Hounds must be certified prior to entry in Open or Veteran Stakes if this is their first trial or possess a title which waives this requirement. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry.**

## Ribbons & Awards

Rosettes shall be awarded for all placements in the regular stakes (1st through NBQ), Best of Breed, and 1st place in both Breeder and Kennel stakes. ASFA will provide a plaque for the winner of Best of Breed. Additional awards shall be offered through the generous donations by members of the IWCA. Donors are listed elsewhere in this premium list.

**Singles**

Any eligible Irish Wolfhound including novice hounds, hounds with breed disqualifications, and hounds disqualified to run in other stakes. Not eligible for Best of Breed.

**Breeder Stake**

Any two Irish Wolfhounds bred by the same person and designated at the time of entry

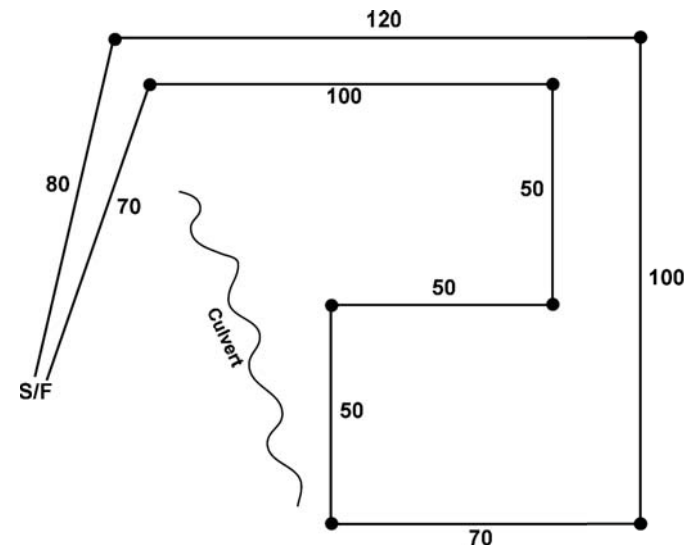
**Kennel Stake**

Any two Irish Wolfhounds owned and kenneled by the same person and designated at the time of entry.

- All entries must be one year of age or over on the day of the trial.
- Stake will be split if the entry in any one stake is 20 or more hounds at the time of the draw.
- Bitches in season and lame hounds will be excused.
- Hounds not present at roll call will be scratched.
- Monorchid, cryptorchid, spayed, or neutered hounds may be entered.
- Muzzles are not required. However, it is the responsibility of the owner to determine if their hound needs to be muzzled.
- Lure machine is battery powered, continuous loop. Back up equipment will be available.
- Lure will consist of highly visible plastic strips.
- There will be a \$5 fine assessed for any loose hound on the field that is not part of the course in progress.
- There will be a \$15 fine assessed for any owner who does not clean up after their hound.

**Course Plan - 700 Yards**

The course will be reversed for finals and again for run-offs and Best of Breed. The Field Committee reserves the right to alter the course plan as necessary due to weather and/or field conditions on the day of the trial.
