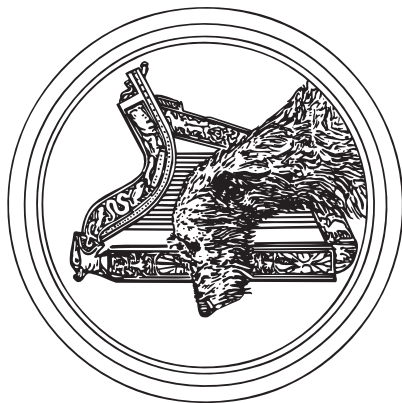

Tests Offered

Junior Courser (JC) - two tests offered:

A hound running alone shall receive a certificate from a judge on one date, and a second certification from another judge at a later date, stating that the hound completed at least a 600-yard course with a minimum of four (4) turns. The two runs may be run on the same date at, or in conjunction with, a National Breed Specialty. Hound must complete the course with enthusiasm and without interruption.

- All entries must be one year of age or over on the day of the trial.
- Bitches in season, lame hounds, and hounds with breed disqualifications will be excused.
- Hounds not present at roll call will be scratched.
- Altered or neutered hounds may be entered.
- Lure machine is battery powered, continuous loop. Back up equipment will be available.
- Lure will consist of highly visible plastic strips.
- There will be a \$5 fine assessed for any loose hound on the field that is not part of the course in progress.

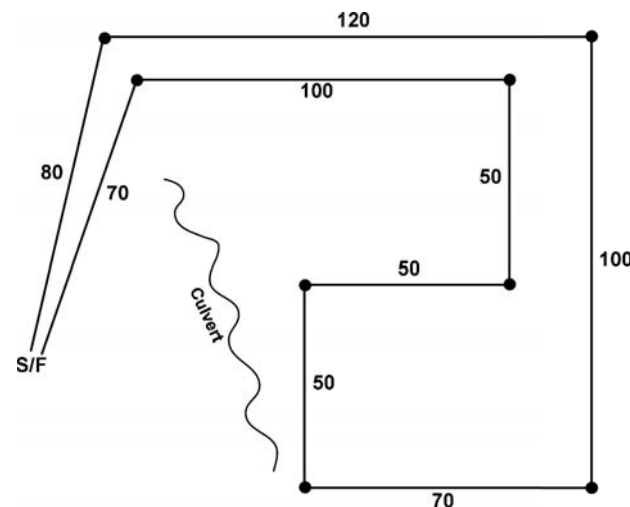
