CLEAN UP AFTER YOUR DOGS!!!! NO DOGS IN LOBBY. YOUR DOGS MUST BE CONTROLLED AT ALL TIMES. No flexi-leads are to be used in and around the hotel for the safety of your dogs and other hotel guests. The Show Committee has designated the hotels as part of the show site. An Event Committee hearing will be held for any hotel complaint including but not limited to failure to clean up after your dog and destruction of the hotel property. See "DOG WASTE."

RV PARKING

For our special event, Seneca Lake State Park will allow 10 RV units during our show dates. All campers must be self-contained. No hook ups are available. New York State Park System has a "Carry In...Carry Out" garbage policy. There is a one-time reservation fee of \$9.00. RV parking fee is \$20.00 per day for non NYS residents or \$15.00 per day for NYS residents. Shower and restroom facilities are available. AIRLINE TRAVEL

There are three International airports in Upstate New York —The Hancock International Airport (SYR) in Syracuse, NY and the Rochester International Airport (ROC) in Rochester, NY. Both are located 1 hour from the show site. The Buffalo International Airport (BUF) is 1½ hours from the show site.

ATTENTION EXHIBITORS!!

RABIES VACCINATION CERTIFICATE — New York State requires you to have proof of current rabies vaccination with you. Tags are not accepted. Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

SHADE TENTS, X-PENS & UNENTERED DOGS must be at least 25 feet back from the ring during show hours. Chairs will be allowed at ringside but no unentered dogs, x-pens, tents (exception will be tent for judges ringside mentoring).

DOG WASTE — Exhibitors caught in the act of doing the right thing on the show site and hotel grounds, by picking up after their hounds, will be presented with a ticket for a special Raffle to be drawn at the end of the specialty. Charges will be brought against any exhibitor who is observed failing to pick up after a dog in their custody and properly disposing of such waste on the show and hotel grounds; an event committee hearing will be called.

FOOD VENDOR — There will be a food concession at the site offering a variety of breakfast and lunch items.

PICNIC TABLES & GRILLS AVAILABLE — The Park has a number of picnic and charcoal grill area combinations for your use. Please be advised, particularly when picnicking, that Seneca State Park has a "Carry In, Carry Out" rubbish policy.

Puppy – 6 months and under 9	Novice	Open

BEST OF BREED – At the discretion of the Judge, up to three (3) Awards of Merit to be awarded to dogs or bitches entered in this class, except those winning BOB, BOS, BOW, WD, WB, SD or SB.

****Points Available for Reserve****

The Irish Wolfhound Club of America, Inc. will award at its National Specialty a three point major to Reserve Winners Dog and Reserve Winners Bitch if the Regular Class Dog entry is twice the required number for a five point major in the division where the National Specialty is held.

NON-REGULAR (ADDITIONAL) CLASSES INVOLVING SINGLE DOG ENTRIES

VETERANS CLASS – Class for dogs and class for bitches 6 years of age or older. **Veterans Note:** 1st place winners of Veteran Dog & Veteran Bitch classes are eligible to compete for Best of Breed if undefeated in any other classes at this show. Neutered Dogs and Spayed Bitches may be entered.

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

As the judge's decision in the Non-Regular Classes involving Multiple Dog Entries is based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

STUD DOG CLASS – For Stud Dog and two or more of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the regular classes, or if a Champion of Record in Best of Breed Competition, but **MUST** be entered in the Stud Dog Class, the Get **MUST** be entered in one of the regular classes. The Stud Dog shall be considered as one entry and requires one entry fee, this being the regular fee plus the additional class fee if the Stud Dog is entered in another class. The Stud Dog must be shown in the ring with the Get. The class will be judged on the merits of the Get.

BROOD BITCH CLASS – Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

BRACE CLASS – Two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner.

TEAM CLASS – Four dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of four handlers. All dogs competing in team competition must have at least one common owner.

MOVE-UP POLICY FOR THE SPECIALTY AND TRIALS — The Club will permit a move-up to the next level class in accordance with AKC regulations. The request for a move-up must be made in writing and presented to the Show Secretary or Trial Secretary at least 30 minutes prior to the start of the specified event, show or trial. Move-up forms will be available at the Secretary's Table.

SWEEPSTAKES REQUIREMENTS & CLASSIFICATION

Dogs shown in Sweepstakes must be entered in one of the regular classes at the regular entry fee and on the regular entry form. Indicate your Sweepstakes Class with the age division in the space provided for "Additional Class." Champions of Record may not be entered. Professional Handlers may only show dogs owned by themselves.

The following classes will be provided for both dogs and bitches:
Junior - 6 mos & Under 9 mos, Junior - 9 mos & Under 12 mos,
Senior - 12 mos & Under 15 mos, Senior - 15 mos & Under 18 mos

JUNIOR SHOWMANSHIP

Novice Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

Open Class - shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

Master Class - for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition from the Open Class. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors who meet the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior ID number by calling the AKC, Judges Education Department 919-233-9767.
