## **License Agreement**

The following are the terms and conditions of the Limited Use License granted by film and photo creators (hereinafter referred to as "the photographer"; film and photo hereinafter are referred to as "image", individually or together as applicable) and the Irish Wolfhound Club of America, Inc. ("IWCA"):

The photographer agrees not to be compensated for the use of the image(s) or include watermarks or copyright information visible on any image.

Images used on the IWCA website and IWCA social media will not be credited. Images published in Harp and Hound will be credited in the same issue in which they are published.

The IWCA is under no obligation to use any image submitted to it.

Use is subject to the following restrictions:

1. This license is for limited use only, and allows the IWCA to: (1) display the image(s) on the IWCA website and/or IWCA social media and at IWCA events (e.g. the IWCA National Specialty, Meet the Breed booths, etc.), cropped, resized, or edited if necessary to meet technical requirements, (2) publish the image(s) in the IWCA's magazine, *Harp and Hound*, resized as needed. If the editor of *Harp and Hound* wants to crop an image, the photographer will be contacted for approval, (3) include the image(s) in video produced by or for the IWCA to be displayed on the IWCA website and/or IWCA social media and at IWCA events, (4) display the image(s) in IWCA educational/promotional materials (brochures, handouts, etc.). In all cases above, use of the image(s) is non-commercial.

- 2. The image(s) may not be used for commercial use (e.g. printing on t-shirts for sale, including in videos for sale, etc.) by the IWCA unless a different license is negotiated with the photographer for that use.
- 3. The image(s) may not be resold, relicensed, or sub-licensed by the IWCA.
- 4. Title and ownership, and all rights now and in the future, of and for the image(s) remain exclusively with the photographer. The photographer may use the image(s) for other purposes, but may not grant an exclusive-use license for the image(s) to any other party.
- 5. The photographer warrants that s/he is the owner of the image(s), holds copyright thereto and is legally entitled to grant this limited use license to the IWCA. Any liability with respect to copyright infringement of the submitted image(s) shall remain with the photographer.

The photographer agrees to the terms of this limited use license by clicking "I Agree" below. Your email program should create a new message to the Committee when you click the agreement. Attach your files to that email, or send it without attachments and a Committee member will contact you with instructions for sending the image(s).
